Data Use Information

Information about Enom's use of your personal data

Enom uses your personal data only when there is a legitimate purpose for doing so. This could be because:

- The data is necessary in order to fulfill a service contract with you;
- You have consented to additional data use beyond the minimum required by contract;
- There is a legitimate purpose pursued by Enom or a third party.

The chart below indicates the legal basis for each data element that we process for each top-level domain (TLD). Please note that for some TLDs, the information we process may differ depending on whether the owner of the domain name is an individual or an organization. In these cases, the data uses for each are indicated below with icons denoting the owner type.

Enom will store your data on our secure platform while the domain is registered with us and for up to seven years following the termination of services.

How and why does Enom process my personal data?

Personal data are processed in order to provide domain name registration and resolution services as well as to provide any other associated services.

Enom will use your data in the following ways:

- To provide client support either to you or to your domain service provider;
- To share with registry operators that require the data in order to provide the requested service;
- To list domain contact details in our tiered access registration directory service (aka "gated Whois");
- To escrow data to a reputable escrow agent mutually approved by Enom and ICANN
